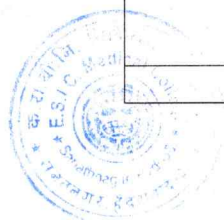

1. These vacancies are provisional and may increase or decrease subject to the actual requirement for patient care and NMC requirement. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice in the interest of patient care.
2. The dates of walk-in Interview as mentioned against the department are final and no change will be made. The candidates have to make necessary arrangements by their own for attending the Walk- in Interview.
3. Reservations will be as per Govt. of India guidelines issued from time to time.
4. In case of non-availability of reserved category candidates in the post of Professor/Associate Professor, the vacancy may be filled up, for less than 45 days, under UR category for fulfilling the urgent requirement.
5. The eligibility criteria including the age, educational qualification and period of experience, as prescribed in the advertisement will be determined with reference to the date of Walk- in Interview.
6. As per ESIC Headquarters Memorandum No. L-11/12/3/2016/MC-Faridabad/MEC dated 22.01.2018 and L-11/12/3/2020/PG Basai/ME CEL dated 28.10.2020, to comply with phase wise minimum MCI requirements;
 - a) Candidate with eligibility for a higher post (Professor/Associate Professor) would be permitted to be interview against a lower post (Associate Professor/Assistant Professor)
 - b) In event of selection of such candidate, the candidate would be considered for the placement with suitable upgradation of the lower post as per eligibility; and recommendation of the selection board.
 - c) The upgradation would be temporary and limited to the tenure of the teaching faculty/until the appointment of regular faculty in the lower post.
7. Age relaxation is applicable to reserved candidates as per rules in force.
8. Candidates intending to apply for multiple cadres in same department shall submit separate applications.
9. As per NMC TEQ dated 14.02.2022 regarding "Determination of equivalence of the qualification of DNB (Broad Specialties) with MD/MS and DNB (Super Specialties) with DM/M.Ch" -The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/M.Ch) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.

Pro-forma enclosed as Annexure-I.

teaching faculty except that their consolidated remuneration will be arrived after reducing the element of NPA.

iv) **No Private Practice is allowed during the tenure of service in ESIC.**

d) Term of Contract:

i) The initial period of contract for Faculty/Super Specialist will be initially for a period of 01 year, extendable every year up to a maximum of 03 years **or** Up to attainment of 70 years of age for Faculty and 75 years of age for Super Specialist (Full time) **or** until joining of regular incumbent, whichever is earlier, subject to satisfactory performance.

ii) The tenure in respect of Senior Residents (3 Yrs) on contract basis; the engagement will be initially for 01 (One) year extendable every year up to three years on satisfactory performance and conduct.

iii) The tenure in respect of Senior Resident (1 Yr) / will be one year only.

iv) The Contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning reason.

v) Senior Resident is a tenure post. Individuals with previous experience in Senior Residency at Central or State Government institutions may have reduced tenure based on the duration of their previous service.

iv) Other terms and conditions will be applicable as issued by competent authority from time to time.

e) The following documents should be submitted at the time of Walk-in Interview:

i) Two copies of recent self attested passport size photograph.

ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research papers, Publications etc.

iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualifications, Experience and Research Papers, Publications, PG Course recognition Certificate etc., Should be submitted at the time of walk-in Interview.

f) Terms & Conditions:

1. In case, the selected candidate resigns, he/she has to serve one month notice period or have to pay one month salary.
2. Candidates selected to the post of Professor/Associate Professor/Assistant Professor/Super Specialist (Sr. Level) and Senior Resident have to deposit an amount Rs.100000/- as security deposit at the time of joining. The security deposit will be forfeited in case;
 - a) The selected candidate resigns/leaves within 01 year except Senior Resident (1 Yr).
 - b) The selected Senior Resident (1 Yr) resigns/leaves within 06 months from date of joining.
 - c) The selected candidate resigns/leaves after 01 year/ 06 months (as the case may be) of joining but fails to fulfill the Notice period conditions.
3. The selected specialist must have a professional indemnity policy which should cover the period as desired by ESIC. The policy is meant to cover the professional liability falling on them as a result of errors and omissions committed by them while rendering professional services.
The minimum sum assured per annum should be
 - i. Rs 30 lakhs: Anesthesiologists, Cardiac Surgeons, Neuro Surgeons, Plastic Surgeons etc.
 - ii. Rs 20 lakhs: for General Surgeons, Gynecologists, and Obstetricians etc.
 - iii. Rs 10 lakhs: for Physicians, Dentists, Radiologists, Pathologists, Chest (Pulmonologists) etc.
 - iv. A copy of the Insurance & Premium Receipt must be submitted within 7 days from the date of engagement.
4. As the contract being for one year, absence for the period of 15 days or beyond without prior permission/approval of Competent Authority will be treated as abandonment of duty and the contract will be terminated without any notice and security deposit will be forfeited.
5. The absence from work for a period of fifteen days without proper permission of the Competent Authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on NMC Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
