#### 1. Eligibility Criteria for the post of Registrar:

Officers possessing a Bachelors degree in law from a recognised university and holding:-

(a) Analogous post on regular basis in Central Government or State Government or courts or tribunals;

OR

(b) Post in Central Government or State Government or courts or tribunals with five years regular service in pre revised pay band -3, Rs. 15600-39100/- with grade pay of Rs. 7600/- i.e. Level 12 in the Pay Matrix;
